## Customer Reviews

Partnership tax is one of the most difficult classes in law school, but Yin and Burke make it as easy to understand as basic federal income tax (that is, it is still difficult, but understandable). The examples are very clear; the problems are helpful, and it is organized to provide students with a logical progression of partnership tax concepts. At less than 400 pages, it is one of the shortest textbooks I've ever used in law school, but that's because the authors don't waste words with meaningless pictures or sidebars. I used the Cunninghams' Logic of Subchapter K in conjunction with this textbook and found it to be very complementary for providing longer explanations and more examples/problems.
